Cono Sur has achieved CarbonNeutral® Delivery certification for 2024 period, in accordance with **The CarbonNeutral Protocol**, the leading global framework for carbon neutrality.

Cono Sur has offset unavoidable GHG emissions associated by the delivery of its wines to international and local markets for the 2022–2023 growing season.

Cono Sur seeks to reduce its impact on climate change over time by internally reducing its greenhouse gas emissions and offsetting the remaining emissions with the help of **Climate Impact Partners**, a specialist in carbon market solutions. **Climate Impact Partners** has more than 25 years of experience running some of the world's largest and most innovative voluntary carbon offset programs.

OBJECTIVES

- Calculate the carbon footprint of its wines' transport to international and local markets.
- Offset the inevitable emissions of CO₂e through high quality verified carbon Offsets (VCU).
- Obtain the CarbonNeutral® Delivery certification.

This assessment has been carried out in accordance with the World Business Council for Sustainable Development and World Resources Institute's (WBCSD/WRI) Greenhouse Gas Protocol; a Corporate Accounting and Reporting Standard. This protocol is considered current best practice for corporate or organizational greenhouse gas emissions reporting. GHG emissions have been reported by the three WBCSD/WRI Scopes.

The emission sources considered in the calculation were the following:

- All emissions generated by mobile sources used for ground transport of products from warehouses to Valparaiso and local ports.
- All emissions arising from sea transport vessels to destination ports.
- All emissions generated by mobile sources used for ground transport of products to retailers at destination.

Equivalent to GEI emissions avoided by 3.419 tons of waste recycled instead of landfilled.

All projects are independently verified to ensure emissions reductions occur. This ensures the highest environmental integrity in the commitment to have an immediate and positive impact on the climate.

To meet **Cono Sur** carbon neutral goal, its offset program provides financing to Projects that are reducing atmospheric emissions now, supporting the transition to a low-carbon global economy.
